The arbitrator's decision will be final and binding on both you and us, and judgment on the decision may be entered in any court having jurisdiction. This agreement affects important legal rights: Neither of us will be able to go to court for disputes that must be arbitrated. NEITHER OF US WILL BE COMMITTED BY THE TERMS OF THIS AGREEMENT TO ARBITRATE UNLESS YOU SIGN BELOW, IN WHICH EVENT WE WILL BOTH BE COMMITTED.
